TERMS AND CONDITIONS OF SALE

ACCEPTANCE

These TERMS AND CONDITIONS OF SALE shall govern all orders for the purchase of products from SignalChem, its subsidiaries, affiliates, SignalChem Pharmaceuticals Inc. and the SignalChem Lifesciences Corporation (hereinafter referred to as "SIGNALCHEM", "we" or "our"). The purchaser (hereinafter referred to as "Purchaser", "you", or "your") will be deemed to have assented to this TERMS AND CONDITIONS OF SALE by ordering products. No variation of these terms and conditions will be binding upon SIGNALCHEM unless agreed to in writing and signed by an authorized representative of SIGNALCHEM.

DEFINITIONS

The term "SIGNALCHEM" as pertaining to this TERMS AND CONDITIONS OF SALE shall mean SignalChem Pharmaceuticals Inc., and SignalChem Lifesciences Corporation interchangeably and may be modified by SIGNALCHEM from time to time.

PAYMENT TERMS

All invoices are issued at time of shipment and are payable within thirty (30) days thereafter, unless otherwise required by SIGNALCHEM. Payment should be made in accordance with the instructions on the invoice issued to you. Please contact us for bank account details when submitting remittance by bank wire transfer.

Any products and services tax, sales tax, use tax, manufacturers tax, occupation tax, excise tax, value added tax, duty, customs, inspection or testing fee, or any other tax, fee or charge of any nature imposed by any government authority or measured by the transaction between SIGNALCHEM and Purchaser will be paid by Purchaser in addition to the purchase price. If SIGNALCHEM is required to pay any such tax, fee or charge, then Purchaser will reimburse SIGNALCHEM immediately upon receiving a request in writing from SIGNALCHEM.

PRICES

Please contact SIGNALCHEM or your local distributor for a current price list. Prices are subject to change without notice.

SHIPPING & DELIVERY

North America: All SIGNALCHEM domestic (Canada and U.S.) orders are shipped FOB Origin, (Prepay and Add). Under this term, transportation and cargo insurance will be arranged for and paid by SIGNALCHEM, and then invoiced by SIGNALCHEM to the customer, and title to the goods passes from SIGNALCHEM to the customer at the point and time of shipment.

<u>International</u>: All SIGNALCHEM international orders are shipped FCA Origin. In addition, as provided for under FCA, SIGNALCHEM will act as a transportation agent and will assume responsibility to arrange for and pay for transportation and insurance to the point of entry in the customer's country, and to invoice the customer for those costs. Under these terms, title to the

CLAIMS

NO RESALE

The Purchaser shall not resell products or any portion of them, in any way, shape or form, without the express written permission of SIGNALCHEM.
