### **Product Description**

The 39 amino acids of PDKtide peptide sequence (KTFCGTPEYLAPEVRREPRILSEEEQEMFRDFDYIADWC) derived from two human proteins: residues 1-14 are based on AKT1 (307-320) and residues 16-39 are based on PKN2/PRK2 (961-984).

### **Molecular Weight**

The theoretical molecular weight is 4771.36

#### **Purity**

The purity was determined to be more than 96.37% by HPLC analysis.

#### **Formulation**

1mg of peptide supplied as a lyophilized powder.

#### Storage and Stability

Store product at -20°C. For optimal storage, aliquot diluted product into smaller quantities and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

#### **Reconstitution Protocol**

Dilute peptide in 40mM Tris-HCl, pH 7.5 solution to a final concentration of 1mg/ml.
