Product Description

Recombinant human CAMK2 γ (c-terminal truncation) was expressed by baculovirus in Sf9 cells using an N-terminal GST tag. The gene accession number is NM 172169.

Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


Scientific Background

CAMK2 γ is a member of the CAMKII family which are ubiquitous serine/threonine protein kinases that have been implicated in diverse effects of hormones and neurotransmitters. CAMK2 γ has six alternatively spliced variants that encode six different isoforms. Some of these variants have been identified in human tumors (1). Transgenic mice expressing a partially calcium-independent mutant form of CAMK2 γ showed 1.5- to 2-fold increase in the thymus of these mice, at least in part due to an increase in the life span of double-positive thymocytes (2). There was an increase in the number of T cells in the secondary lymphoid organs that had acquired an antigen-dependent memory phenotype.



Specific Activity



The specific activity of CAMK2 γ was determined to be 1,260 nmol/min/mg as per activity assay protocol and was equivalent to 220 nmol/min/mg as per radiometric assay.

Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: C14-10G)

Active CAMK2 γ (0.1 μ g/ μ l) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active CAMK2 γ for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl $_2$ and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250 μ M.

Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled H_2O . Add fresh DTT prior to use to a final concentration of $50\mu M$.

ADP-Glo[™] Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-GloTM Reagent Kinase Detection Reagent

Substrate (Catalog #: A15-58)

Autocamtide 2 synthetic peptide substrate (KKALRRQETVDAL-amide) diluted in distilled H₂O to a final concentration of 1 mg/ml.

Co-factor (Catalog #: C02-39B)

Ca2+/Calmodulin Solution II, 10x: Solution with 50ng/µl Calmodulin, 4mM CaCl2, 10mM Tris-HCl, pH7.2.

Assay Protocol

The CAMK2γ assay is performed using the ADP-GloTM Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the CAMK2γ reaction. The ADP- GloTM Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active CAMK2γ, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 10μL enzyme dilution at the desired concentration, with Kinase Dilution Buffer IX (1x), in a pre-chilled 96-well plate.
- Step 2. Prepare a Substrate/Cofactor/ATP mixture as follows (25μM ATP example):

- **Step 3.** Transfer the following reaction components prepared in Step 2 to a 384-well opaque plate bringing the reaction volume up to 5μ L:
 - **Component 1.** 2μl of diluted Active CAMK2γ (Catalog #C14-10G)
 - Component 2. 3µl of Substrate/Co-factor/ATP mix as prepared in the table above. This initiates the reaction
- **Step 4.** Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- **Step 5.** Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5μl of ADP-GloTM Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- **Step 7.** Then add 10μ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
