Product Description

Recombinant full-length human TRIB2 was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The TRIB1 gene accession number is NM_021643.

Formulation

Recombinant protein stored in 50mM Tris-HCI, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background

TRIB2 or tribbles homolog 2 proteins encode one of three members of the Tribbles family that share a Trb domain, which is homologous to protein serine-threonine kinases, but lacks the active site lysine and probably lacks a catalytic function. TRIB2 protein interacts and modulates the activity of signal transduction pathways in a number of physiological and pathological processes. TRIB2 is regulated by inflammatory stimuli in myeloid (THP-1) cells. TRIB2 can act as an oncogene that inactivates the transcription factor C/EBPalpha (CCAAT/enhancerbinding protein alpha) and causes acute myelogenous leukemia (1). TRIB2 is a p65-interacting negative regulator of NF-kappa-B-dependent transcription (2).


