#### **Product Description**

Recombinant human TAOK3 (1-463) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The TAOK3 gene accession number is NM 016281.

#### **Gene Aliases**

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCI, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at  $-70^{\circ}$ C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

#### **Scientific Background**

TAOK3 or TAO kinase 3 is a member of the serine/threonine-protein kinase family that inhibits the basal activity of Jun kinase and is negatively regulated by epidermal growth factor (EGF) (1). Overexpression of TAOK3 may activate the ERK1/ERK2 and JNK/SAPK targets. TAOK3 is highly expressed in peripheral blood leukocytes (PBLs), thymus, spleen, kidney, skeletal muscle, heart and liver (2).





The specific activity of TAOK3 was determined to be **33** nmol/min/mg as per activity assay protocol and was equivalent to **283** nmol/min/mg as per radiometric assay.

# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: T26-11G)

Active TAOK3 ( $0.1\mu g/\mu l$ ) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active TAOK3 for optimal results).

#### Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl<sub>2</sub> and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250\mu$ M.

#### Kinase Dilution Buffer IX (1x) (Catalog #: K01-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled  $H_2O$ . Add fresh DTT prior to use to a final concentration of  $50\mu M$ .

# ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-Glo<sup>TM</sup> Reagent Kinase Detection Reagent

#### **Substrate** (Catalog #: P15-58)

PKCtide peptide substrate (ERMRPRKRQGSVRRRV) diluted in distilled H<sub>2</sub>O to a final concentration of 1mg/ml.

#### **Assay Protocol**

The TAOK3 assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the TAOK3 reaction. The ADP- Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using Juciferase/Juciferin reaction.

- Step 1. Thaw the Active TAOK3, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15µL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

- Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to  $5\mu$ L:
  - Component 1. 3µl of diluted Active TAOK3 (Catalog #T26-11G)
  - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10µl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
