## **Product Description**

Recombinant full-length human NDR1 was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM\_007271.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### **Scientific Background**

NDR or Nuclear Dbf2-related protein is a serine-threonine kinase in the subgroup of the AGC kinase family that is regulated by Mob proteins (1). Fas and TNF $\alpha$  receptor stimulation activates human NDR by promoting phosphorylation at the hydrophobic motif. NDR acts as a novel pro-apoptotic kinase and key member of the RASSF1A/MST1 signaling cascade (2). NDR is crucial for the fidelity of mitotic chromosome alignment in mammalian cells and is incorporated into the HIV-1 particles and cleaved by the HIV-1 protease. NDR-driven centrosome duplication requires Cdk2 activity and Cdk2-induced centrosome amplification is affected upon reduction of NDR activity.



# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: S49-10G)

Active NDR ( $0.1\mu g/\mu l$ ) was diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active NDR for optimal results).

## Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl<sub>2</sub> and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250\mu$ M.

#### Kinase Dilution Buffer IX (1x) (Catalog#: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled  $H_2O$ . Add fresh DTT prior to use to a final concentration of  $50\mu M$ .

## ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo™ Reagent Kinase Detection Reagent

#### Substrate (Catalog #: C01-58B)

Modified PKA-sub synthetic peptide substrate (modified-CGRTGRRNSI-amide) was diluted in 1X PBS, 2.5mM EDTA, 5mM DTT, to a final concentration of 1mg/ml.

#### **Assay Protocol**

The NDR assay is performed using the ADP-Glo<sup>TM</sup> Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the NDR reaction. The ADP- Glo<sup>TM</sup> Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active NDR, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15µL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

| Component                    | Amount (µL) | Component           | Amount (µL) |
|------------------------------|-------------|---------------------|-------------|
| 10mM ATP Solution            | 1           | Substrate at 1mg/mL | 80          |
| Kinase Assay Buffer III (5x) | 79          |                     |             |

- **Step 3.** Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5µL:
  - Component 1. 3µl of diluted Active NDR (Catalog # \$49-10G).
  - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10µl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
