## **Product Description**

Recombinant human PIK3R1 SH3 domain (2-82) was expressed in E. coli cells using an N-terminal GST tag. The gene accession number is NM 181523.3.

GRB1; PI3-kinase subunit p85-alpha

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

#### **Scientific Background**

The PIK3R1 (Phosphoinositide-3-Kinase Regulatory Subunit 1) gene encodes the regulatory subunit p85a of phosphoinositide 3-kinase (PI3K), a critical signaling enzyme involved in various cellular processes, including cell growth, survival, proliferation, and migration. The p85a regulatory subunit contains multiple domains, including the Src homology 3 (SH3) domain. The SH3 domain is a protein module of approximately 50-70 amino acids that is involved in protein-protein interactions, particularly with prolinerich motifs in target proteins. SH3 domains are crucial for mediating signaling pathways, cellular adhesion, and intracellular trafficking by promoting the assembly of signaling complexes. The SH3 domain within PIK3R1 is likely important for protein-protein interactions, enabling the association of PI3K with other signaling molecules and facilitating the transduction of cellular signaling cascades.


