# **Product Description**

Recombinant human FGFR1 (399-822) was expressed by baculovirus in Sf9 cells using an N-terminal GST tag. The gene accession number is NM\_023110.

## Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

## Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


## Scientific Background

FGFR1 (also known as FLT2) is a member of the Fibroblast Growth Factor Receptor family that constitute a family of four membrane-spanning tyrosine kinases (FGFR1-4) which serve as high-affinity receptors for 17 growth factors (FGF1-17). The FGF Receptor family plays an important role in multiple biological processes, including mesoderm induction and patterning, cell growth and migration, organ formation and bone growth (1). FGFR1 is alternatively spliced generating multiple splice variants that are differentially expressed during embryo development and in the adult body (2).

# Activity Assay Protocol

**Reaction Components** 

#### Active Kinase (Catalog #: F04-11G)

Active FGFR1 (FLT2)  $(0.1\mu g/\mu)$  diluted with Kinase Dilution Buffer X (Catalog #: K20-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active FGFR1 (FLT2) for optimal results).

#### Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl<sub>2</sub> and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250\mu$ M.

#### Kinase Dilution Buffer X (Catalog #: K20-09)

Buffer components: 40mM Tris-HCl, pH 7.4, 20mM MgCl<sub>2</sub>, 2.5 mM MnCl<sub>2</sub> and 0.1mg/mL BSA. Add fresh DTT prior to use to a final concentration of  $50\mu$ M.

#### ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-Glo<sup>TM</sup> Reagent Kinase Detection Reagent

Substrate (Catalog #: P61-58)

Poly (4:1 Glu, Tyr) synthetic peptide substrate diluted 25mM Tris-HCl, pH 7.5, solution to a final concentration of 1mg/mL.

Cofactor: 2.5M MnCl<sub>2</sub> (Catalog #: M40-09-25)

Diluted in distilled H<sub>2</sub>O to a working concentration of 1M.

#### Assay Protocol

The FGFR1 (FLT2) assay is performed using the ADP-Glo<sup>TM</sup> Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the FGFR1 (FLT2) reaction. The ADP- Glo<sup>TM</sup> Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active FGFR1 (FLT2), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15µL enzyme dilution with Kinase Dilution Buffer X at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

Component	Amount (μL)	Component	Amount (μL)
10mM ATP Solution	1	Substrate at 1mg/mL	80
Kinase Assay Buffer III (5x)	78	1 M MnCl <sub>2</sub>	1

**Step 3.** Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5μL:

Component 1. 3µl of diluted Active FGFR1 (FLT2) (Catalog #F04-11G)

**Component 2.** 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.

- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer X.
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10μl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- Step 9. Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
