### **Product Description**

Mouse active form TNF-beta (34-end) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The protein accession number is <u>P09225.</u>

### Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

### **Storage and Stability**

Stored at desiccated below -20°C. It is stable at 4°C between 2-7 days. For long term storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### Scientific Background


TNF-beta is a member of the tumor necrosis factor cytokine family that are primarily expressed on lymphocytes that control lipid metabolism. TNF-beta is highly inducible, secreted, and forms heterotrimers with lymphotoxin-beta which anchor lymphotoxin-alpha to the cell surface. TNFbeta acts as a novel therapeutic route for the treatment of dyslipidemia (1). The presence of TNF-beta accelerates the initiation of immune responses and protects the host from larger viral challenges (2).
