Product Description

Recombinant full-length human SRC was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM 005417.

Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


Scientific Background

SRC family belongs to non-receptor tyrosine kinases. SRC was originally identified as a transforming protein of the Rous sarcoma virus (RSV) that had enzymatic ability to phosphorylate tyrosine in protein substrates (1). SRC is overexpressed and activated in a large number of human malignancies and has been linked to the development of cancer and progression to distant metastases (2). In addition to increasing cell proliferation, a key role of SRC in cancer seems to be the ability to promote invasion and motility, functions that might contribute to tumour progression.



The specific activity of SRC was determined to be **97 nmol** /min/mg as per activity assay protocol.

Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: S19-18G)

Active SRC ($0.1\mu g/\mu l$) diluted with Kinase Dilution Buffer IV (Catalog #: K24-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active SRC for optimal results).

Kinase Dilution Buffer IV (Catalog #: K24-09)

Kinase Assay Buffer II (Catalog #: K02-09) diluted at a 1:4 ratio (5X dilution) with 50ng/µl BSA solution.

Kinase Assay Buffer II (Catalog #: K02-09)

Buffer components: 25mM MOPS, pH 7. 2, 12.5mM β -glycerol-phosphate, 20mM MgC1₂, 12.5mM MnC1₂, 2mM EDTA. Add 0.25mM DTT to Kinase Assay Buffer prior to use.

[33P]-ATP Assay Cocktail

Prepare 250 μ M [33 P]-ATP Assay Cocktail in a designated radioactive working area by adding the following components: 150 μ l of 10mM ATP Stock Solution (Catalog #: A50-09), 100 μ l [33 P]-ATP (1mCi/100 μ l), 5.75ml of Kinase Assay Buffer II (Catalog #: K02-09). Store 1ml aliquots at -20°C.

10mM ATP Stock Solution (Catalog #: A50-09)

Prepare ATP stock solution by dissolving 55mg of ATP in 10ml of Kinase Assay Buffer II (Catalog #: K02-09). Store 200 μ l aliquots at -20° C.

Substrate (Catalog #: S30-58)

SRC synthetic peptide substrate (KVEKIGEGTYGVVYK) diluted in 20mM Tris-HCl, pH 7.5 to a final concentration of 1mg/ml.

Assay Protocol

- Step 1. Thaw [33P]-ATP Assay Cocktail in shielded container in a designated radioactive working area.
- Step 2. Thaw the Active SRC, Kinase Assay Buffer, Substrate and Kinase Dilution Buffer on ice.
- Step 3. In a pre-cooled microfuge tube, add the following reaction components bringing the initial reaction volume up to 20µl:

Component 1. 10µl of diluted Active SRC (Catalog #\$19-18G)

Component 2. 5µl of 1mg/ml stock solution of substrate (Catalog #S30-58)

Component 3. 5µl distilled H₂O (4°C)

- **Step 4.** Set up the blank control as outlined in step 3, excluding the addition of the substrate. Replace the substrate with an equal volume of distilled H₂O.
- Step 5. Initiate the reaction by the addition of 5 μl [33P]-ATP Assay Cocktail bringing the final volume up to 25μl and incubate the mixture in a water bath at 30°C for 15 minutes.
- **Step 6.** After the 15 minute incubation period, terminate the reaction by spotting 20 μ l of the reaction mixture onto individual pre-cut strips of phosphocellulose P81 paper.
- **Step 7.** Air dry the pre-cut P81 strip and sequentially wash in a 1% phosphoric acid solution (dilute 10ml of phosphoric acid and make a 1L solution with distilled H₂O) with constant gentle stirring. It is recommended that the strips be washed a total of 3 intervals for approximately 10 minutes each.
- Step 8. Count the radioactivity on the P81 paper in the presence of scintillation fluid in a scintillation counter.
- Step 9. Determine the corrected cpm by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.

Calculation of [P³³]-ATP Specific Activity (SA) (cpm/pmol)

Specific activity (SA) = cpm for 5 μ l [33P]-ATP / pmoles of ATP (in 5 μ l of a 250 μ M ATP stock solution, i.e., 1250 pmoles)

Kinase Specific Activity (SA) (pmol/min/μg or nmol/min/mg)

Corrected cpm from reaction / [(SA of ³³P-ATP in cpm/pmol)*(Reaction time in min)*(Enzyme amount in µg or mg)]*[(Reaction Volume) / (Spot Volume)]
