## **Product Description**

Recombinant human PASK (981-end) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM\_015148.

#### Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### **Scientific Background**


PASK or PAS domain containing serine/threonine kinase regulates the function of many intracellular signaling pathways involved in stress. PASK is involved in sensing environmental changes in light intensity, oxygen concentration and redox potential. Through interaction with IRS-1, PASK has been proposed as a counterregulatory mechanism in insulin and cytokine signaling (1). PASK can phosphorylate and inactivate glycogen synthase in vitro. Efficient phosphorylation requires residues 444 to 955 of PASK between the PAS and catalytic kinase domain and this interaction is inhibited by the PAS domain.



# Activity Assay Protocol

**Reaction Components** 

#### Active Kinase (Catalog #: P08-11G)

Active PASK ( $0.1\mu g/\mu l$ ) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active PASK for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl<sub>2</sub> and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250\mu$ M.

Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled H<sub>2</sub>O. Add fresh DTT prior to use to a final concentration of 50 $\mu$ M.

#### ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-Glo™ Reagent Kinase Detection Reagent

Substrate (Catalog #: Z16-58)

ZIPtide synthetic peptide substrate (KKLNRTLSFAEPG) diluted in distilled H<sub>2</sub>O to a final concentration of 1mg/ml.

#### Assay Protocol

The PASK assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the PASK reaction. The ADP- Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active PASK, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15µL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25 µM ATP example):

- Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to  $5\mu$ L:
  - **Component 1.** 3µl of diluted Active PASK (Catalog #P08-11G)
  - **Component 2.** 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10μl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- Step 9. Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
