# **Product Description**

Recombinant full-length human RGS19 was expressed in E. coli cells using an N-terminal His tag. The protein accession number is P49795.

#### **Formulation**

Recombinant protein stored in 50mM sodium phosphate, pH 7.0, 300mM NaCl, 150mM imidazole, 0.25mM DTT, 25% alycerol.

### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

#### **Scientific Background**

RG\$19, also known as Regulator of G protein Signaling 19, is a member of the RG\$ protein family that plays a crucial role in modulating G protein-coupled receptor (GPCR) signaling. The RG\$ proteins act as GTPase-activating proteins (GAPs) for G alpha subunits of heterotrimeric G proteins, accelerating the intrinsic GTP hydrolysis activity of the G alpha subunits and thereby terminating the signaling cascade initiated by GPCRs. RG\$19 is one of the less characterized members of the RG\$ protein family. Its exact functions, signaling pathways it modulates, and physiological significance are areas of ongoing research.


