Recombinant human HTRA4 (159-376) protein was expressed in E. coli cells using an N-terminal His-tag. The protein accession number is <u>NM 153692</u>. This protein contains a catalytic domain of serine protease HTRA4.

Recombinant protein stored in 50mM sodium phosphate pH 7.0, 300mM NaCl, 150mM imidazole, 0.25mM DTT and 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background


HTRA1 is a serine protease with a conserved trypsin domain and a PDZ domain. As other related family members, HTRA4 may function as a secreted oligomeric chaperone protease to degrade misfolded secretory proteins. HrtA4 may contribute to shallow trophoblast invasion in preeclampsia (1) and imply a potential application as a biomarker for this disorder (2).
