### **Product Description**

Recombinant human EIF2AK4 (GCN2) pseudokinase domain (260-539) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM 001013703.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### **Scientific Background**

GCN2, or general control nonderepressible 2, is a conserved serine/threonine protein kinase crucial for cellular responses to amino acid deprivation. Activated by uncharged tRNAs during amino acid starvation, GCN2 phosphorylates eukaryotic initiation factor 2a (eIF2a), globally inhibiting protein synthesis and selectively translating mRNAs like ATF4. This pathway, identified in yeast and conserved in mammals, plays roles in immune responses, metabolic homeostasis, and the integrated stress response (ISR). Dysregulation of GCN2 is implicated in diseases, including metabolic disorders. The pathway's evolutionary conservation underscores its fundamental role in cellular stress responses.


