#### **Product Description**

Recombinant human IKK $\beta$  (1-662) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The IKK $\beta$  gene accession number is NM 001556.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCI, pH 7.5, 150mM NaCI, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### **Scientific Background**

IKK $\beta$  is a serine/threonine protein kinase that phosphorylates the I-kappa-B protein which is an inhibitor of the transcription factor NF-kappa-B complex. Phosphorylation of I-kappa-B protein triggers the degradation of the inhibitor via the ubiquitination pathway, thereby activating NF-kappa-B complex. The activity of IKK $\beta$  is stimulated by TNF and IL1 and IKK $\beta$  forms a heterodimer that interacts with NIK (1). Overexpression of catalytically inactive IKK $\beta$  blocks cytokine-induced NF-kappa-B activation. Aspirin and sodium salicylate can specifically inhibit IKK $\beta$  activity in vitro and in vivo by binding to IKK $\beta$  to reduce ATP binding (2).



## **Specific Activity**



The specific activity of IKK $\beta$  was determined to be 10.8 nmol/min/mg as per activity assay protocol and was equivalent to 60 nmol/min/mg as per radiometric assay.

#### **Purity**



The purity of IKK $\beta$  was determined to be >90% by densitometry, approx. MW ~105kDa.

# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: I03-10BG)

Active IKKß (0.1µg/µl) diluted with Kinase Dilution Buffer X (1x) (Catalog #: K20-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active IKKß for optimal results).

### ADP-Glo™ Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo™ Reagent Kinase Detection Reagent

#### Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200 mM Tris-HCl, pH 7.4, 100 mM MgCl<sub>2</sub> and 0.5 mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250 \mu M$ .

## Substrate (Catalog #: I33-58)

IKKtide synthetic peptide substrate (KKKKERLLDDRHDSG-LDSMKDEE) diluted in distilled H2O to a final concentration of 1mg/ml.

#### Kinase Dilution Buffer X (1x) (Catalog #: K20-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold water. Add fresh DTT to the aliquot prior to use to a final concentration of  $50\mu M$ .

#### **Assay Protocol**

The IKKβ assay is performed using the ADP-Glo<sup>TM</sup> Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the MNK1 reaction. The ADP- Glo<sup>TM</sup> Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active IKKβ, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15 μL enzyme dilution at the desired concentration, with Kinase Dilution Buffer IX (1x), in a pre-chilled 96-well plate.
- **Step 2.** Prepare a substrate/ATP mixture as follows (25  $\mu$ M example):

- Step 3. Transfer the following reaction components prepared in Step 2 to a 384-well opaque plate bringing the reaction volume up to  $5\mu L$ :
  - Component 1. 3μl of diluted Active IKKβ (Catalog #103-10BG)
  - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add  $10\mu$ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
