Product Description

Recombinant full-length human GSK3 β was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM 001146156.


Scientific Background

GSK3 β is a serine threonine protein kinase that was originally identified as the kinase that phosphorylates and inhibits glycogen synthase (1). GSK3 β is ubiquitously present in human tissues and implicated in the regulation of several physiological processes, including the control of glycogen and protein synthesis by insulin, modulation of the transcription factors AP-1 and CREB. Transient transfection of human GSK3 β into Chinese hamster ovary cells stably transfected with individual human tau isoforms leads to hyperphosphorylation of tau at all the sites investigated with phosphorylation-dependent anti-tau antibodies (2).



Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: G09-10G)

Active GSK3 β (0.1 μ g/ μ l) diluted with Kinase Dilution Buffer III (Catalog #: K23-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active GSK3 β for optimal results).

Kinase Dilution Buffer III (Catalog #: K23-09)

Kinase Assay Buffer I (Catalog #: K01-09) diluted at a 1:4 ratio (5X dilution) with 50 ng/µl BSA solution.

Kinase Assay Buffer I (Catalog #: K01-09)

Buffer components: 25mM MOPS, pH 7.2, 12.5mM β -glycerol-phosphate, 25mM MgC1₂, 5mM EGTA, 2mM EDTA. Add 0.25mM DTT to Kinase Assay Buffer prior to use.

[33P]-ATP Assay Cocktail

Prepare 250 μ M [33 P]-ATP Assay Cocktail in a designated radioactive working area by adding the following components: 150 μ l of 10mM ATP Stock Solution (Catalog #: A50-09), 100 μ l [33 P]-ATP (1mCi/100 μ l), 5.75ml of Kinase Assay Buffer I (Catalog #: K01-09). Store 1ml aliquots at -20°C.

10mM ATP Stock Solution (Catalog #: A50-09)

Prepare ATP stock solution by dissolving 55mg of ATP in 10ml of Kinase Assay Buffer I (Catalog #: K01-09). Store 200 μ l aliquots at -20 $^{\circ}$ C.

Substrate (Catalog #: G50-58)

GSK 3 substrate (YRRAAVPPSPSLSRHSSPHQ(pS)EDEEE) diluted in distilled H₂O to a final concentration of 1mg/ml.

Assay Protocol

- Step 1. Thaw [33P]-ATP Assay Cocktail in shielded container in a designated radioactive working area.
- Step 2. Thaw the Active GSK3β, Kinase Assay Buffer, Substrate and Kinase Dilution Buffer on ice.
- Step 3. In a pre-cooled microfuge tube, add the following reaction components bringing the initial reaction volume up to 20µl:

Component 1. 10µl of diluted Active GSK3β (Catalog #G09-10G)

Component 2. 5µl of 1mg/ml stock solution of substrate (Catalog #G50-58)

Component 3. 5µl distilled H₂O (4°C)

- **Step 4.** Set up the blank control as outlined in step 3, excluding the addition of the substrate. Replace the substrate with an equal volume of distilled H₂O.
- Step 5. Initiate the reaction by the addition of 5μl [33P]-ATP Assay Cocktail bringing the final volume up to 25μl and incubate the mixture in a water bath at 30°C for 15 minutes.
- Step 6. After the 15 minute incubation period, terminate the reaction by spotting 20µl of the reaction mixture onto individual pre-cut strips of phosphocellulose P81 paper.
- Step 7. Air dry the pre-cut P81 strip and sequentially wash in a 1% phosphoric acid solution (dilute 10ml of phosphoric acid and make a 1L solution with distilled H₂O) with constant gentle stirring. It is recommended that the strips be washed a total of 3 intervals for approximately 10 minutes each.
- Step 8. Count the radioactivity on the P81 paper in the presence of scintillation fluid in a scintillation counter.
- **Step 9.** Determine the corrected cpm by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.

Calculation of [P³³]-ATP Specific Activity (SA) (cpm/pmol)

Specific activity (SA) = cpm for 5 μ l [33P]-ATP / pmoles of ATP (in 5 μ l of a 250 μ M ATP stock solution, i.e., 1250 pmoles)

Kinase Specific Activity (SA) (pmol/min/μg or nmol/min/mg)

Corrected cpm from reaction / [(SA of ³³P-ATP in cpm/pmol)*(Reaction time in min)*(Enzyme amount in µg or mg)]*[(Reaction Volume) / (Spot Volume)]
