
Scientific Background

PDGFRa (platelet-derived growth factor receptor a) is a member of the PDGFR family of membrane receptors with intrinsic tyrosine kinase activity. Aberrant expression of PDGFRa has been linked to developmental abnormalities in vertebrate models and has been implicated in multiple disease states in humans. There is widespread expression of PDGFRa in renal cell types involved in fibrotic and sclerosing processes (1). PDGF and its receptor PDGFRa are inducers of fibrosis in the repair phase of inflammatory bowel disease and they may also be involved in the active inflammatory phase (2). PDGFRa(T674I) is one of the mutant forms of PDGFRa.



Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: P12-12EG)

Active PDGFRa (E675G Y676C) ($0.1\mu g/\mu l$) diluted with Kinase Dilution Buffer X (Catalog #: K20-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active PDGFRa (E675G Y676C) for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl₂ and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250μ M.

Kinase Dilution Buffer X (Catalog #: K20-09)

Buffer components: 40mM Tris-HCl, pH 7.4, 20mM MgCl₂, 2.5 mM MnCl₂ and 0.1 mg/mL BSA. Add fresh DTT prior to use to a final concentration of 50µM.

ADP-Glo[™] Kinase Assay Kit (Promega, Cat # V9101)

Assay Protocol

The PDGFR α (E675G Y676C) assay is performed using the ADP-GloTM Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the PDGFR α (E675G Y676C) reaction. The ADP- GloTM Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using Juciferase/Juciferin reaction.

- Step 1. Thaw the Active PDGFRα (E675G Y676C), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15μL enzyme dilution with Kinase Dilution Buffer X at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25μM ATP example):

Kinase Assay Buffer III (5x)	78	1M MnCl ₂	1

- **Step 3.** Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5μ L:
 - Component 1. 3µl of diluted Active PDGFRa (E675G Y676C) (Catalog # P12-12EG)
 - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- **Step 4**. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer X.
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- **Step 7.** Then add 10μ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
