#### **Product Description**

Recombinant full-length human 14-3-3 sigma was expressed by baculovirus in \$f9 insect cells using an N-terminal His tag. The gene accession number is NM 006142.

#### **Formulation**

Recombinant protein stored in 50mM sodium phosphate, pH 7.0, 300mM NaCl, 150mM imidazole, 0.1mM PMSF, 0.25mM DTT, 25% glycerol.

#### Storage and Stability

Store product at  $-70^{\circ}$ C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### **Scientific Background**

14-3-3 $\sigma$  or stratifin is a protein that is strongly induced by gamma irradiation and other DNA-damaging agents (1). The induction of 14-3-3 $\sigma$  is mediated by a p53 responsive element. Exogenous introduction of 14-3-3 $\sigma$  into cycling cells results in a G2 cell cycle arrest (2). Knockout of 14-3-3 $\sigma$  in cells showed that the cells are unable to maintain cell cycle arrest after DNA damage. The 14-3-3sigma -/- cells die as they enter mitosis. This process is associated with a failure of the 14-3-3 $\sigma$ -deficient cells to sequester the proteins that initiate mitosis and prevent them from entering the nucleus. Thus, 14-3-3 $\sigma$  plays an important role in maintaining the G2 checkpoint in cells and preventing mitotic death.
