#### **Product Description**

Recombinant full-length human AMPK (combination of A1/B1/G1 subunits) was expressed by baculovirus in Sf9 insect cells using a C-terminal His tag. The gene accession numbers for the three subunits (A1/B1/G1) are NM\_006251, NM 006253, and NM 002733.

#### Formulation

Recombinant protein stored in 50mM sodium phosphate, pH 7.0, 300mM NaCl, 150mM imidazole, 0.1mM PMSF, 0.25mM DTT, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### Scientific Background

AMPK is a heterotrimer protein kinase consisting of a  $\alpha$ catalytic subunit, and non-catalytic  $\beta$  and  $\gamma$  subunits. AMPK is an important energy-sensing enzyme that monitors cellular energy status (1). In response to cellular metabolic stresses, AMPK is activated and phosphorylates and inactivates acetyl-CoA carboxylase (ACC) and betahydroxy beta-methylglutaryl-CoA reductase (HMGCR), key enzymes involved in regulating biosynthesis of fatty acid and cholesterol (2).



The specific activity of AMPK was determined to be 125 nmol /min/mg as per activity assay protocol and was equivalent to 739 nmol/min/mg as per radiometric assay.

## Activity Assay Protocol

**Reaction Components** 

Active Kinase (Catalog #: P47-10H)

Active AMPK (A1/B1/G1) ( $0.1\mu g/\mu l$ ) diluted with Kinase Dilution Buffer IX (1x) (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active AMPK (A1/B1/G1) for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl<sub>2</sub> and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of  $250\mu$ M.

Kinase Dilution Buffer IX (1x) (Catalog #: K01-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold water. Add fresh DTT to the aliquot prior to use to a final concentration of  $50\mu$ M.

ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo<sup>™</sup> Reagent Kinase Detection Reagent

Substrate (Catalog #: S07-58)

SAMStide synthetic peptide substrate (HMRSAMSGLHLVKRR) diluted in 20mM Tris-HCl (pH 7.5) solution to a final concentration of 1mg/ml.

**AMP Solution** (Catalog #: A46-09)

0.5mM AMP solution in 25mM MOPS (pH 7.2) buffer.

#### Assay Protocol

The AMPK (A1/B1/G1) assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the AMPK (A1/B1/G1) reaction. The ADP- Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

**Step 1.** Thaw the Active AMPK (A1/B1/G1), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15 μL enzyme dilution at the desired concentration, with Kinase Dilution Buffer IX (1x), in a pre-chilled 96-well plate.

Step 2. Prepare a substrate/Cofactor/ATP mixture as follows (25 µM ATP example):

Component	Amount (µL)	Component	Amount (μL)
2.5mM ATP Solution	2	Substrate at 1mg/mL	40
Kinase Assay Buffer III (5x)	38	AMP Solution	40

Step 3. Transfer the following reaction components prepared in Step 2 to a 384-well opaque plate bringing the reaction volume up to  $5\mu$ L:

Component 1. 2µl of diluted Active AMPK (A1/B1/G1) (Catalog #P47-10H).

**Component 2.** 3µl of Substrate/Cofactor/ATP mix as prepared in the table above. This initiates the reaction.

- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10μl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- Step 9. Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
