#### **Product Description**

Recombinant full-length human PIP4K2C was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is <u>BC028596</u>.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at  $-70^{\circ}$ C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### **Scientific Background**

PIP4K2C (also known as phosphatidylinositol-5-phosphate 4-kinase, type II, gamma) is a member of the PIP kinase family that plays an important role in a wide variety of cell functions (1). PIP4K2C is found in the cytosol and surrounding plasma membrane and its presence in the endoplasmic reticulum seems to be a prerequisite for PIP2 synthesis. PIP4K2C play an important role in the production of phosphatidylinositol bisphosphate (PIP2) in the endoplasmic reticulum (2).



# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: P76-102CG)

Active PIP4K2C ( $0.1\mu g/\mu l$ ) diluted with 1x Lipid Kinase Buffer (Catalog #: L01-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active PIP4K2C for optimal results).

#### **Lipid Kinase Buffer (5x)** (Catalog #: L01-09)

250mM HEPES pH 7.5, 250mM NaCl, 10mM MgCl $_2$ , 2.5mM EGTA, 125 $\mu$ g/mL BSA and 0.2% Triton X-100. Dilute to 1x and add 0.05mM fresh DTT prior to use.

2.5M MnCl<sub>2</sub> Solution (Catalog #: M40-09)

Lipid Dilution Buffer (1x) (Catalog #: L21-09)

25mM HEPES pH 7.5 and 0.5mM EGTA.

# ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo<sup>TM</sup> Reagent Kinase Detection Reagent

1M MgCl<sub>2</sub> Solution - Required for ADP-Glo reaction

#### 250 µM ATP Assay Solution

Prepare the ATP assay solution by diluting ATP solution, 10 mM (Promega, Cat # V9101) to 250  $\mu$ M in 1x Lipid Kinase Buffer (prepared from Lipid Kinase Buffer 5x; Catalog #: L01-09).

#### Substrate (Catalog #: P428-59)

PI(5)P:PS substrate solution contains 250 $\mu$ M of PI(5)P and 2000 $\mu$ M of PS in 1x Lipid Dilution Buffer.

#### **Assay Protocol**

The PIP4K2C assay is performed using the ADP-Glo<sup>TM</sup> Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the PIP4K2C reaction. The ADP- Glo<sup>TM</sup> Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active PIP4K2C, Lipid Kinase Buffer, Substrate and Lipid Dilution Buffer on ice.
- Step 2. In a pre-cooled 96-well opaque plate, add the following reaction components bringing the initial reaction volume up to 20µl:

Component 1. 10µl of diluted Active PIP4K2C (Catalog #P76-102CG)

Component 2. 5µl of 1x Lipid Kinase Buffer with 4mM MnCl<sub>2</sub> final concentration

Component 3. 5µl of PI(5)P:PS substrate (Catalog# P428-59) (sonicate for 1 minute prior to use)

- **Step 3.** Set up the blank control as outlined in step 2, excluding the addition of the substrate. Replace the substrate with an equal volume of Lipid Dilution Buffer.
- Step 4. Initiate the reaction by the addition of 5µl of 250 µM ATP Assay Solution thereby bringing the final volume up to 25µl. Shake the reaction mixture in the 96-well opaque plate for 2 minutes and continue the incubation at 30°C for 40 minutes.
- Step 5. After the 40 minute incubation period, terminate the reaction and deplete the remaining ATP by adding 25µl of ADP-Glo™ Reagent with 10mM MgCl₂. Shake the 96-well plate and then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 6. Then add 50µl of the Kinase Detection Reagent to the 96-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 7. Read the 96-well reaction plate using the KinaseGlo Luminescence Protocol on a GloMax plate reader (Promega; Cat# E7031).
- **Step 8.** Determine the corrected activity (RLU) by removing the blank control value (see Step 3) for each sample and calculate the kinase specific activity as outlined below.
